1.1.1 – Institution has the mechanism for well planned curriculum delivery and documentation. Explain in 500 words

The college at the beginning of every academic year prepares an academic calendar. It is a proposed Calendar prepared by the Committee in charge for that academic year. It is in Co- ordination with the SPPU examination and

holidays given. Every department prepares its syllabus planning before starting of the Session. This is prepared by every faculty member, it is then given to the HOD, Vice - principal and principal for its finalization. The same is forwarded to the NAAC Co- ordinator for documentation of the same. The students of the FYBA/B.COM and B.sc. are given an introductory lecture on curriculum and exam pattern existing and to be followed. The implementation of the same is carried out by the Committees Concerned. The Curriculum is of course designed by the university to be followed by the Colleges. Some of the staff members are involved in the syllabus planning of the SPPU. The teachers at the beginning of the Session give their workload, Time table and tentative plan of the activities to be conducted by each department. The teaching faculty sees that it completes its teaching in the number of working days given as per the Circulars. Same faculty members as per their Concerned departments take their students for study tours, field visits conduct Seminar or take students students to other colleges for attending seminar. The college also conducts certain academic elocution Competitions related to topic in economics filmshows for students of English are conducted, essay Competition etc. Teachers go as experts to different colleges to give lectures. The method of teaching is more with blackboard & chalk, along with power- point presentation asking students to use technology. The students are given instructions and explanations in both the medium English and Marathi. The exam department displays every notice concerned with examination as given by SPPU. Notices regarding students Internal and External examinations details of the filling of forms, its last date and date with late fee is displayed. The details of the commencement of each examination are displayed whether internal or external. The time table along with the subjects and dates of practical and Viva Voce are put up on the notice board. The submission date of each practical is decaled by the teachers concerned and informed to the students well in advance most of the faculty members of the concerned subjects which have practical also are invited as external Senior supervisors, on examination squads etc. The declaration of the result is in general put on the notice board. i.e total pass percentage of that faculty and the names of the first three student of each faculty. The teachers prepare Question bank for the students as per their subjects and set Question papers for the same. Some of the faculty members are also paper setters at SPPU examinations. Every faculty also keeps recorded of its results of each academic year. The college thus tries its best to be in line as per the planning and implementation.

#### Feedback Obtained

The college has Plans and accordingly the feedback forms for different stakeholders are prepared . The college has now for the current year 2018 2019 prepared feedback forms as per the changes of U. G. C. it is therefore curriculum oriented we have three stakeholder feedbacks. (1) Students (2) Alumini and (3) Parents. The college has selected the above three Stakeholders. The questionnaire prepared for students is academic, related to the syllabus, and of course allround development of students. It is seen that the feedback from the students is analyzed with a weightage of five marks per question. The rating was on an average more than 3.0. The forms after analyzing is discussed, and the concerned changes are brought and the action is taken accordingly. I Improvement in teaching method or some infrastructure facility to be provided are consider. The students do feel that the Curriculum is useful for them in their Career. The Alumini feedback analyzed also has a rating of above 3.0. They do suggest certain changes to make syllabus more employment oriented but since college is affiliated to SPPU it cannot be changed. But the Alumini are in general Satisfied with the college functioning. The feedback form of parents is also related to syllabus and analysis shows parents respondents remarks. The parents find that the Childs academic professional needs are taken into account in the syllabus and it is useful for them to get employment, they showed overall satisfaction regarding syllabus personality development and Carrere opportunities. The mechanism of the college is simple so far as the feedback is concerned. The hard copy forms are Circulated among the students on last day of their exams. The Alumini are given the hardcopy forms on the day of their meet or if any Alumini visit to college for their personal works, the forms are duly

filled by them. Parents forms are filled during the meeting called for parents else when they came for some enquiry regarding their child. The Committee confidentially Scrutinizes the forms, it then goes to the Coordinates. The action to be taken is decided by the Committee. Suggestions regarding improvement in teaching, Curriculum or giving employment to students is considered and action for the same is undertaken.

The institution has adequate infrastructure facility to create ideal teaching learning environment. The institution has sufficient number of spacious and well ventilated class rooms. Each classroom has elevated platform for the teacher to conduct his classes. The provision makes the board visible to the students and helps the teachers to make eye contract with the students. The faculty of arts, commerce and science have one peon each to look after the cleanliness of the classrooms. For proper upkeep of the infrastructural facilities the management has appointed a team of technicians like electrician, carpenter, computer technician, gardener and sweeper. Power outage in lonavala is a regular feature. Education facilities such as computers that store vital data such as admission details of students face the risk of losing it when the power is disrupted. The college has generator Kirloskar as backup to keep computers, xerox Machine light and fans on in case of power cut. The library is situated in a spacious hall with proper ventilation. The shelves are stacked with text books, reference books, journals and audiovisual cassettes. English and Marathi dailies are made available for the staff and students. The library is partially automated. The reading hall has the capacity to accommodate about 30 students at a time. The library attendant and library peon look after the upkeep of library infrastructure. The working hours of library is from 9 a.m. to 4 p.m. The college auditorium its used for academic functions and cultural programmes. The college has an IQAC room where the members of IQAC assemble for meetings concerning the development of the college. Sports and NSS have separate office rooms. The college cafeteria serves healthy food to the students. The IQAC chairman monitors the cafeteria to see that quality food is served to the students. The water purifiers are professionally serviced at regular intervals.
